

Privacy Policy

THE HOEROES' MOVEMENT APPLICATION

- This privacy policy governs your use of the software application The Heroes' Movement for mobile devices that was created by The Heroes' Movement. The Application is for membership purposes. Features include but are not limited to membership profile, community, commenting, photo, video sharing, bio, podcast streaming, geolocations, content, loyalty rewards, and mobile sharing through third party social media.

USER PROVIDED INFORMATION

- The Application obtains the information you provide when you download and register the Application. Registration with us is optional. However, please keep in mind that you may not be able to use some of the features offered by the Application if you are not a current member of The Heroes' Movement or unless you register with us.
- When you register with us and use the Application, you generally provide (a) your name, email address, age, user name, password and other registration information; (b) transaction-related information, such as when you make purchases, respond to any offers, or download or use applications from us; (c) information you provide us when you contact us for help; (d) credit card information for purchase and use of the Application, and; (e) information you enter into our system when using the Application, such as contact information and project management information.

DO THIRD PARTIES SEE AND/OR HAVE ACCESS TO INFORMATION OBTAINED BY THE APPLICATION?

- No aggregated, anonymized data is transmitted to external services. We will share your information with third parties only in the ways that are described in this privacy statement. We may disclose User Provided and Automatically Collected Information:
 - As required by law, such as to comply with a subpoena, or similar legal process;
 - When we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
 - With our trusted services providers who work on our behalf, do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.
 - If The Heroes' Movement, is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our Web site of any change in ownership or uses of this information, as well as any choices you may have regarding this information.

WHAT ARE MY OPT-OUT RIGHTS?

- You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

CHILDREN

- We do not use the Application to knowingly solicit data from or market to children under the age of 13. We will delete such information from our files within a reasonable time.

SECURITY

- We are concerned about safeguarding the confidentiality of your information. We provide physical, electronic, and procedural safeguards to protect information we process and maintain. For example, we limit access to this information to authorized

If you reside outside the United States your information will be transferred, processed and stored there under United States privacy standards.
